

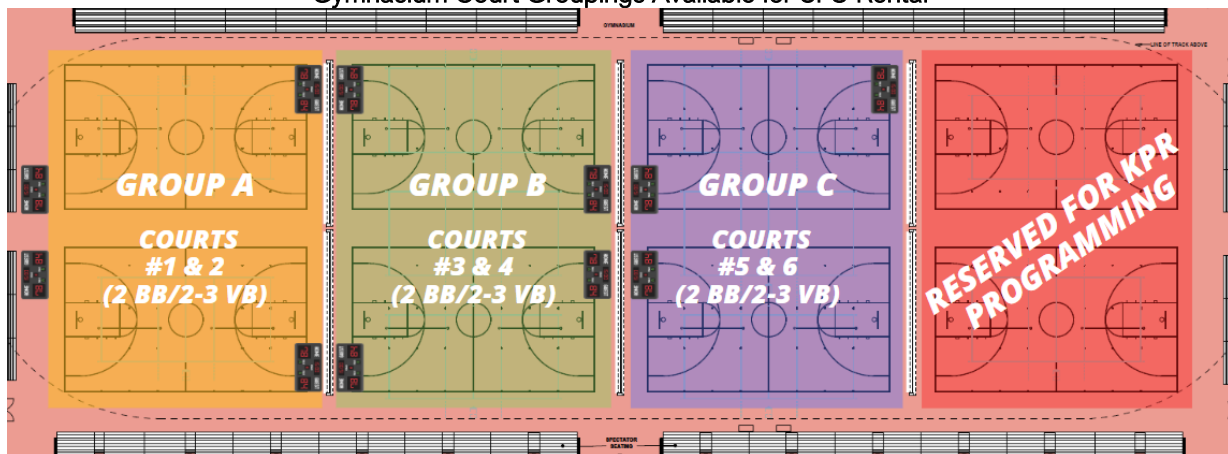
SportsPlex FREQUENT USER

GYMNASIUM & FIELD TURF FALL, WINTER & SPRING DESIGNATIONS

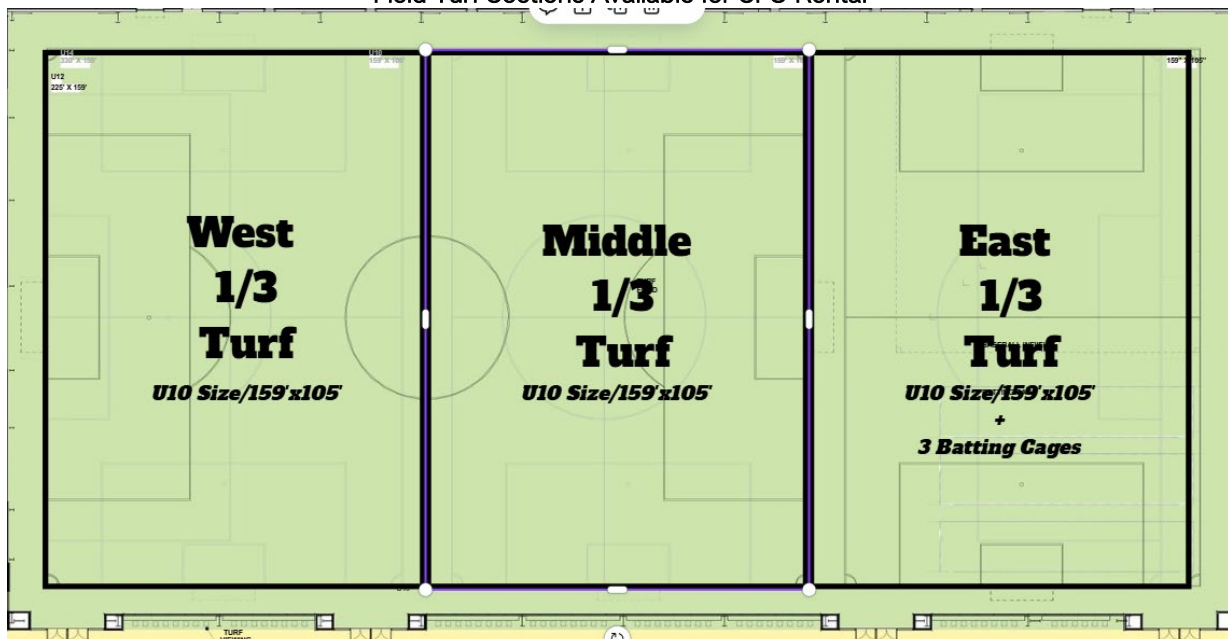
Specific calendar months require extensive usage of the SportsPlex gymnasium and field turf spaces. To accommodate multi-sport needs and users, the Kearney SportsPlex has developed a 'SportsPlex Frequent User' (SFU) designation. This designation shall assist in establishing clear guidelines that will assist SportsPlex staff in making fair, equitable, transparent, and consistent facility allocation decisions.

Two (2) basketball courts or three (3) volleyball courts (within the gymnasium) and 1/3 of the field turf may be specifically designated on Monday through Friday, from 5:00 p.m. to 9:00 p.m. for use by SFUs. A maximum of three (3) SFUs may be selected for the gymnasium and field turf, during each season designation. Fall designation begins September 14 through November 29. Winter designation begins November 30 through February 14. Spring designation begins February 14 through April 30. Each designation may result in a sport/s preference as a result of a specific sports season running concurrently. For example, the Winter designation concurrently runs with a typical basketball and indoor soccer season. Spring designation concurrently runs with a typical volleyball season and pre-season soccer/baseball/softball.

To qualify as an SFU, a sports association/organization/club must agree to the following:

- 1) Provide published bylaws that include the election of board members and officers, as well as the overall governance of the association/organization/club.
- 2) Rental of two (2) basketball courts or three (3) volleyball courts or 1/3 of the field turf for a minimum of two (2) consecutive hours between 5:00 p.m. to 9:00 p.m. for a minimum of two (2) or three (3) days per week during one of the three designations:
 - a. FALL: September 14 thru November 29
 - b. WINTER: November 30 thru February 14
 - c. SPRING: February 15 thru April 30
- 3) If selected as an SFU, provide an initial deposit of \$1,250 within thirty (30) days before the program start date or as mutually agreed upon with SportsPlex Management (which will be applied towards the SFU's total rental fees). Any deposit remaining will be refunded at the conclusion of the designation and any additional rental fees will be billed monthly. ***See proposed hourly rental rates on Page 2.
- 4) Priority use will go towards sports associations/organizations/clubs that are comprised of a minimum of seventy-five (75) participants, who are 18 years of age and under.
- 5) Submit a Certificate of Liability Insurance to SportsPlex Management listing the City of Kearney as an Additional Insured with minimum coverage of \$1,000,000 per occurrence, \$2,000,000 general aggregate. This coverage must be maintained during the entire term of this rental (see attached example).

Requests to become a recognized SFU shall be submitted via the SFU Application to the Kearney SportsPlex Director (in-person or by email at labrandt@kearneygov.org):

- Submittal Deadline: July 24th for Fall SFU Designation (September 14 to November 29)
- Submittal Deadline: September 4th for Winter SFU Designation (November 30 to February 14)
- Submittal Deadline: October 23rd for Spring SFU Designation (February 15 to April 30)

SportsPlex Management will review and evaluate all received applications within two weeks of the submission deadlines and work to identify users who offer associations/organizations/clubs that will greatly assist with maximizing consistent weekly usage of the facility. Following the first year of SportsPlex operations, first preference may be given to returning SFU users.

Please note that the Kearney SportsPlex Director or their designee has the authority to reschedule or cancel any previously scheduled Monday through Friday events as a result of rentals of tournaments and events using the majority of the gymnasium or field turf, which will provide significant positive economic impact to the City of Kearney and the Kearney SportsPlex.
